The purpose of this form is for tax filers who have filed an extension with the IRS to submit the required income information to complete federal verification. Enter the adjusted gross income (AGI) that you expect to report on your 2017 federal tax return, considering earned income, business income (loss), rental income (loss) etc. from your financial records and anticipated adjustments against income. Make sure to submit copies of all W2s, and if no W2, a statement of why no W2 is available. The 2018-2019 FAFSA requires 2017 federal tax information which is due on April 17, 2018. Form 4868 grants automatic extension for six months, which expires October 16, 2018. Therefore, to submit 2017 tax extension documents after October 16, 2018, you will also need to submit an additional IRS document granting you an additional extension to file your 2017 federal return.
