The purpose of this form is for tax filers who have filed an extension with the IRS to submit the required income information to complete federal verification. Enter the adjusted gross income (AGI) that you expect to report on your 2018 federal tax return, considering earned income, business income (loss), rental income (loss) etc. from your financial records and anticipated adjustments against income. Make sure to submit copies of all W2s, and if no W2, a statement of why no W2 is available. The 2020-2021 FAFSA requires 2018 federal tax information which was due on April 15, 2019. Form 4868 grants an automatic extension for six months, which expired October 15, 2019. Therefore, to submit 2018 tax extension documents after October 15, 2019, you will also need to submit an additional IRS document granting you an additional extension to file your 2018 federal return.
